Members acknowledge that rodeo events and bull riding, including IBR, Inc. sanctioned events, are inherently dangerous activities. Members further acknowledge that participation in an IBR event (whether as a competitor, independent contractor, official, laborer, volunteer or observer) exposes the participant to substantial and serious hazards and risks of property damage, personal injury, and/or death. Each member, in consideration of his membership in the IBR and his being permitted to participate in an IBR sanctioned event in any capacity, does, by such membership and participation, agree to assume hazards and risks.

Each Member further agrees to discharge, waive, release, and covenant not to sue the IBR, all IBR Sponsors, all Members (including, without limitation, Contestants, Stock Contractors, Committees, Producers and Contract Personnel) and any other IBR sanctioned event production entity (and each party's respective officers, directors, employees, property owners and agents), from all claims, demands and liabilities for any and all property damage, personal injury and/or death arising from such Member's participation in an IBR sanctioned event. This discharge, waiver and release includes claims, demands, and liabilities that are known or unknown, foreseen or unforeseen, future or contingent, and include claims, demands, and liabilities arising out of the negligence of the parties so released by such Member. Furthermore, where permitted by applicable law, this discharge, waiver, release also includes claims, demands and liabilities arising out of the gross negligence or willful and wanton negligence of the parties so released. This discharge, waiver and release also include claims, demands and liabilities by a Member for the indemnities and contribution arising from property damage, personal injury and/or death to a third party. In the event that any provision of the discharge, waiver and release is determined to be invalid for any reason, such invalidity shall not affect the validity of any of the other provisions, which other provisions, shall remain in full force and effect as if the discharge, waiver and release had been executed with the invalid provision eliminated.

The undertakings and Covenant of the foregoing provisions shall be binding upon each Member, his or her heirs, legal representatives, successors and assigns.

Each Member (including, without limitation, contestants, stock contractors, Committees, Producers and Contract Personnel) agrees to indemnify and save and hold harmless the IBR and all IBR Sponsors from any and all claims, demands and liabilities for any and all property damage, personal injury and/or death asserted by a third party (defined as any party other than the Member, IBR or an IBR Sponsor) and arising, or such Member's participation in IBR sanctioned events.
